ATHLETIC COMMISSION
PROFESSIONAL BOXING CONTRACT

This contract is made this _____ day of _____, 200__ by and between Promoter: _____ a duly licensed promoter under the laws of the State of Nebraska (hereinafter "Promoter"), and Boxer: _____ of the City of _____ and the State of _____, Federal ID# _____ (hereinafter "Boxer").

Boxer agrees to enter into a boxing contest to be held at _____ in the City of _____, and the State of Nebraska on the _____ day of _____, 200__ for _____ rounds to a decision with _____ of the State of _____ and Federal ID# _____. This contest shall be at a weight not to exceed _____ pounds. Weigh-ins for this bout will take place at _____ in the City of _____ and the State of Nebraska on the _____ day of _____, 200__ at _____ o'clock. All weigh-ins shall be taken on scales as provided by the promoter.

Promoter will pay the Boxer and the Boxer will accept a purse in the amount of \$ _____ Dollars and additional expenses as follows; _____. All purse amounts shall be paid immediately after the conclusion of the bout directly to the Boxer, unless otherwise agreed to in writing. Promoter agrees to make no deductions from the purse monies to be paid to the Boxer unless the Boxer agrees to such deductions, and only if such deduction is itemized as an addendum to this contract.

Boxer understands and agrees that proof of/and complete results of all required medical testing to include but not limited to; physical examination, eye examination, Hepatitis B Virus & Hepatitis C Antibody test, HIV Virus test, in addition to the signed and completed "Professional Boxing Contract" must be submitted to the Commission office a minimum of 14 days prior to the scheduled event. Failure to comply may result in disciplinary action to include suspension, fine or cancellation of the bout at the discretion of the Athletic Commissioner.

Boxer shall not be entitled to the compensation described above or any part thereof if an official of the Commission determines that Boxer: 1) Did not enter into the contract in good faith or had any collusive understanding or agreement regarding the termination of the match, 2) Boxer did not give a good faith exhibition of his skills, 3) Boxer has violated any of the laws, rules or regulations administered by the Commission.

Promoter shall pay to the Commission any compensation to be forfeited under the terms of the proceeding paragraph. To the extent authorized under state law, the Commission shall thereupon dispose of said compensation in accordance with the applicable statutes and regulations, including but not limited to forfeiture to the Commission or payment of all or a portion thereof to Boxer minus any statutory/regulatory penalties. All parties agree to accept and to be bound by the decision of the Commission, which shall be final.

It is understood and agreed that the Commission must approve all gloves, all main event gloves will be new and all gloves will be furnished by the Promoter at his own expense.

It is understood and agreed that the rights and obligations of the parties hereto shall be governed by, and construed according to the laws of the State of Nebraska. The terms of this agreement shall in all respects be in conformity with the laws of the State of Nebraska, and the rules and regulations now or hereafter adopted by its Commission, which laws and rules are hereby made a part of and incorporated into this agreement.

Boxer understands that by participating in a contest or exhibition of boxing, that the Boxer is engaging in an abnormally dangerous activity. The Boxer further understands that this participation subjects the Boxer to a risk of severe injury or death. The Boxer, with full knowledge of this risk, nonetheless, agrees to enter into this agreement and hereby waives any claims that the Boxer or Boxer's heirs may have against the Commission and the State of Nebraska as a result of any injury the Boxer may suffer as a result of Boxer's participation in any contest or exhibition of boxing in the State of Nebraska.

The parties, jointly and severally hereby indemnify and hold harmless the State of Nebraska and the Commission, and each of their members, agents, and employees in their individual, personal and representative capacities against any and all claims, suits and actions, brought against the persons named in this paragraph by reason of this agreement and all other matters relating thereto, and against any and all expenses, damages, charges and costs, including court costs and attorney fees which may be incurred by the persons and entities named in this paragraph as a result of said claims, suits and actions.

Promoter and Boxer agree to fulfill in good faith the terms and conditions of this contract during the period covered by this contract. It is understood and agreed that if Boxer enters into another contest prior to this bout and lessens his value, the Promoter shall have the option to modify or cancel this contract. If Promoter or Boxer breaches this contract, the non-breaching party shall have all remedies available at law or in equity. The Commission reserves the right to take disciplinary action against the Boxer.

No modification or amendment to this contract shall be binding upon the parties unless the same is in writing, signed by the respective parties hereto, and filed with and approved by the Commission. This contract shall be submitted to and approved by the Commission in accordance with the rules and regulations.
